Erin has dedicated her career to seeking justice for people harmed during air travel. As a partner in Kreindler's aviation practice, she represents the interests of victims severely injured or killed in general aviation accidents and commercial airline disasters. Erin is part of the Kreindler litigation team representing 34 victims of the January 2025 midair collision in Washington, DC, serving as a member of the court-appointed Plaintiffs' Steering Committee. She also represents 14 passengers in the litigation arising from the February 2025 crash-landing of Delta Flight 4819 in Toronto, serving as co-chair of the Plaintiffs' Executive Committee. She is widely recognized as an authority on the Montreal Convention, the international treaty on commercial air travel.

Erin maintains a robust practice representing passengers who have been seriously injured during commercial flights.

Erin's other major cases at Kreindler include the Southwest Airlines Flight 1380 catastrophic engine failure and the Liberty Helicopters doors-off tour helicopter crash in the East River. For the past six years, Erin has played a key role in Kreindler's fight against Boeing in the Ethiopian Airlines Flight 302/737 MAX litigation. She was appointed by the court as a member of the Plaintiffs' Executive Committee for the Ethiopian Airlines Flight 302 cases and was instrumental in the victims' families' effort to overturn the Deferred Prosecution Agreement (DPA) between Boeing and the Department of Justice (DOJ). She also handles a significant docket of personal injury matters on behalf of passengers seriously injured aboard commercial airline flights.
