After many years of litigation, Steven, along with the plaintiffs' team, established liability against the Libyan government for its role in the 1988 terrorist plane bombing over Lockerbie, Scotland. We recovered over \$2.7 billion, approximately \$10 million for the family of each victim.

Steven has been involved in litigating numerous aviation crash cases involving commuter and military aircraft as well as related product liability cases. He has also appeared pro hac vice in several state and federal courts throughout the country. Notable aviation crash trials Steven has handled include the Korean Air Lines disaster and the USAF CT-43 crash in Croatia. Other significant cases include:
